

Santander railcard offer Terms and conditions

These terms and conditions govern our **'railcard offer'** for eligible customers. The offer period starts on 9th April 2024 and ends on 30th April 2024 but may, at our sole discretion, be withdrawn earlier (see general term 4 below).

To be eligible for the 4 Year Railcard, you must:

- $\circ\,$ Be aged between 20 and 25 on 30th June 2024.
- Complete an application for a new Everyday, Santander Edge or Edge Up account within the offer period (see general term 4).
- Pay at least £500 into your Santander account by 14th May 2024.
- Setup Online and/or Mobile banking.
- Continue to hold your Santander account until you receive the Santander Railcard.

You won't qualify for the offer if any of these apply:

- You're not a UK resident.
- You have an existing open Santander bank account before 9th April 2024.
- You have an existing Santander Railcard. Only the person named on the account will be able to claim the Railcard.
- You open a joint account. The offer is only available to sole accounts with one Railcard per account on offer.

Receiving the Railcard

- We will review your Santander account after the eligibility period ends. If you qualify, the Railcard code will be sent out by 31st July 2024. You will have 30 days from receiving the Railcard code to redeem it.
- You will receive a unique code which only you can redeem. Only one code will be sent per customer regardless of the number of accounts opened.
- You will need to have access to Online and/or Mobile banking to access your Railcard code.
- The code can be redeemed by visiting secure.santander-railcard.co.uk. You can choose a digital or physical Railcard.
- We reserve the right to not send out a Railcard code if we suspect the offer is being abused.

General terms

- 1. In these Terms, 'we', 'us' or 'our' means Santander UK plc.
- 2. In these Terms, 'you' means Person or Persons named on the account.
- 3. The offer is not transferable.
- 4. We reserve the right to withdraw, alter or replace this offer at any time and without notice to you.
- 5. These Terms apply in addition to and should be read together with the terms and conditions contained in the Railcard offer Terms & Conditions, Santander 16-25 Railcard Terms & Conditions, our General Terms & Conditions and the Key Facts Document which govern the Santander account.
