- purchased any 1 of the following: a new Santander buildings and contents home insurance policy, Santander contents only policy or Santander buildings only policy from our range of Classic or Premier cover. Your policy can be purchased online, over the phone or in branch.
- paid your initial monthly instalment or full policy premium.
- held the policy for a minimum of 45 consecutive days and the policy is still active.

We have the sole decision on whether any eligibility requirements have or haven't been met.

By entering the prize draw you're confirming you've read, accepted and agreed to be bound by these rules and any other requirements set out in the material relating to this promotion.

- The following customers aren't eligible to enter the prize draw:
- existing Santander Home Insurance customers who are renewing their policy;
- and employees of Santander UK plc.

# 2. When will the prize draw take place?

- The prize draw will take place monthly and you'll only be entered into 1 of the monthly prize draws.
- All eligible customers will be entered into the prize draw for the month following the policy start date.
- The first monthly draw will take place within 11 weeks of the campaign starting for any eligible policies purchased within the first 6 weeks of the campaign commencing.
- Subsequent draws will take place 1 month after the previous draw until the month after the campaign ends.

#### 3. How do I enter?

- If you meet the eligibility criteria you'll automatically be entered into the prize draw.
- Only 1 entry per address will be entered into the prize draw.

   You must do this within 30 days of purchasing your policy. You may still be selected as a winner if you opt out, in this instance you'll have no obligation to accept the prize if offered.

## 4. What are the prizes?

- Each winner will receive a cashback payment equal to the amount of their annual premium payable. You'll need to retain your policy and keep up your payments to remain covered.
- The annual insurance premium is the annual cost of your policy including any
  optional extras, add-ons and Insurance Premium Tax. The prize relates to winning
  a sum equal to the cost of the 1st year's premium. It won't include any additional
  costs incurred as a result of a mid-term adjustment at a later date and doesn't
  apply in the case of any subsequent renewals.
- There'll be 20 winners drawn every month.

### 5. How will I receive my prize?

- Once the winners have been chosen, we'll notify you within 30 days of the draw, confirming your cashback amount and how you'll receive your payment.
- If you have a Santander current account, the cashback will be paid directly into this account and will show on your statement as 'Ins Cashback'.
- If you don't hold a Santander current account, a cheque will be sent.
   For joint policies, a cheque will be sent to the first named policyholder.
- The winners can't exchange or transfer their prize.

### 6. How are the winners chosen?

- All eligible customers will be entered into the prize draw and the winners will be randomly selected using a random number generator.
