1. You can enter if you're a tax resident of the United Kingdom. The prize draw is open to new or existing Santander customers aged 18 years or older. You can't enter if you're a Santander employee or associated with the draw.
2. Santander ISA Managers Limited is the promoter of this offer. They're registered in Scotland at 287 St Vincent Street, Glasgow G2 5NB, United Kingdom. The registered number is SC151605.
3. If you're entered into the prize draw, you agree to these terms and conditions and any other requirements of the promotion.
4. Purchase is necessary. A valid Santander Investment Hub account and a £1,000 investment are required.

9. **Further Prize Details and Conditions:**

 - b. The prize will be available for home delivery or collection from the retailer site. Delivery is available nationwide up to 250 miles. Price subject to change based on the winner's location.
 - c. The prize includes an Electric Vehicle charging point up to the value of £1,750.
 - d. The winner will not be the first registered owner of the car.
 - e. The existing mileage on the car will not exceed 1,000.
