D.2	Key risks regarding the issuer and the guarantor In purchasing Securities, investors assume the risk that the Issuer and the Guarantor may become insolvent or otherwise to unable to make all payments due in respect of the Securities. There are a wide range of factors which individually together could result in the Issuer and the Guarantor becoming unable to make all payments due in respect of the Securities.
