At a glance

- G4S collects and delivers the cash.
- Santander processes the deposits and provides the change.
- Choose from 3 price bands.
- Select between 1 and 5 G4S collections a week.
- Choose to have cash collected from one, some or all of your sites (subject to a G4S site survey).

To use Cash Carrier Light, you'll need to enter into a separate agreement with G4S. They'll be responsible for providing you with the collection and delivery services.

How it works

Cash Carrier Light brings you an efficient and convenient way to manage your cash and deposit cheques. G4S collect your deposits and deliver your change up to 5 times a week, depending on your business needs.

Fees

Choose the price band that matches how much cash you normally deposit. We've set out the Santander fees for depositing cash and for ordering change below.

We've also included an estimate of the fees G4S may charge to give you an indication of the total cost. The actual G4S fees will be detailed in your agreement with G4S.

Fee example based on pricing from 1 September 2026:

If you choose 'Up to £5,000', deposit £4,500 in one collection and also order £400 of change:

- We'll charge you £17.50. That's a £7.50 deposit fee and £10 for the change.
- Also, G4S would charge you a collection fee. In the example given we've estimated this would be £17+VAT.

If a single collection contains more than one deposit slip, G4S will charge you one collection fee and we'll charge you a fee for each deposit.

Get cash collected

- G4S provides collection and delivery services Monday to Saturday from 9am to 5pm. You must book at least 1 collection a week. However, you can cancel or rebook for free as long as you give G4S at least 2 days' notice.
- Your deposit can contain up to £500 of coins and a maximum of 25 coin bags in total.
- You can be sure your cash deposit is secure. G4S cover losses whilst the cash is in transit, as long as the value of the deposit does not exceed your chosen limit. Check your agreement with G4S for further details.
- Includes cheque deposits. These don't count towards the total deposit value, take a day longer to clear, and you'll need to pay standard cheque-deposit fees.

Get change delivered

- Get up to £500 of change sent straight to your site.
- Choose the types of coins you want.
- Get up to 5 deliveries a week, scheduled with your deposit collections.
- We base each order on a single bag with no more than 25 coin bags inside with a maximum limit of £500.
