Objectives:	The objective is to provide you with protection against future movement in rates of exchange.				
	The product achieves its objective by Santander UK plc agreeing on the Trade Date the terms of a Time Option Forward with you under which both parties agree to exchange a fixed amount of one currency for another at a fixed rate of exchange within a specific range of dates in the future.				
	Specifically, on the Trade Date, both you and Santander UK plc agree to exchange the Notional Amount of the Notional Currency in exchange for the other currency in the Currency Pair, in tranche sizes and dates of your choosing, between Settlement Date A and Settlement Date B, at the Forward Rate. The product provides the flexibility to exchange amounts of one currency for the other currency in the Currency Pair at any time between Settlement Date A and Settlement Date B, provided (1) such individual exchange amounts are less than or equal to the Notional Amount; and (2) that in aggregate no more than the Notional Amount has been exchanged; and (3) that in aggregate the entire Notional Amount must be exchanged on or before Settlement Date B.

Term	The relevant Settlement Dates of the Time Option Forward will be set out in the confirmation for the product. The Time Option Forward is a bilateral agreement that cannot ordinarily be terminated unilaterally by either you or Santander UK plc. The product terms provide that if certain exceptional events occur Santander UK plc or you may terminate the product early. These events are specified in more detail in your ISDA master agreement or FX Facility Letter (as applicable) or in the confirmation. The amount (if any) you pay or receive on such early termination is likely to be different from the scenarios described in this document.				

### What are the risks and what could I get in return?

Risk indicator:



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class.

This rates the potential losses from future performance at a very high level.

#### **Performance Information:**

This product can be used to hedge your exposure against the volatility of exchange rates. For this product the main factor affecting return and what you will get will vary on how the spot rate performs against the Forward Rate.

#### What could affect my return positively?

If between Settlement Date A and Settlement Date B, the currency you are purchasing strengthens and the currency you are selling weakens, then you would benefit by purchasing currency at the Final Exchange Forward Rate, in comparison to the spot rate and your returns with this product would be higher.

#### What could affect my return negatively?

If between Settlement Date A and Settlement Date B the currency you are purchasing weakens, and the currency you are selling strengthens then you would be in a worse position by purchasing currency at the Final Exchange Forward Rate, compared to the spotrate. Thus, your return with this product would be lower.

It is important to note that severely adverse market conditions are difficult to predict, and foreign exchange rates can be z ero, therefore you could end up paying for a currency that is nominally worth nothing at the prevailing spot rate.

#### What happens if Santander UK plc is unable to pay out?

The product is not protected by the Financial Services Compensation Scheme or any other investor compensation or guarantee scheme. This means that if Santander UK plc is unable to pay out, you may not receive any amount from Santander UK plc under Time Option Forward.

#### What are the costs?
